Governance & Risk Management

- Are you still able to operate safely? Have you reviewed your risk assessments and business continuity plans?
- ☐ Are you exploring new activities in response to COVID-19? Do you know if any updates need to be made to your risk assessments, governing documents, contracts, or otherwise?
- Are your directors or trustees aware of their duties in the context of COVID-19, including if your organisation encounters significant financial or operational difficulties?
- □ Is your governing body meeting more frequently? Do you know if meetings can be held legally online or by telephone?
- Do you have an upcoming annual general meeting (AGM), members' or shareholders' meeting that might need to be postponed or held virtually?



- Do you have upcoming events that need to be cancelled or rescheduled? Do you know what existing contracts you have (e.g. venue) and your rights to cancel or postpone?
- ☐ Are you unable to perform your obligations under a contract? If so, are you aware of the implications and do you know your legal rights for example, to temporarily suspend a service or grant-funded programme or terminate the contract?



- □ Have you considered whether it is possible to negotiate alternative means of performing an obligation under a contract (e.g. moving an in-person training to online)?
- Are you relying on others to perform services or pay you? If so, do you know if they will be able to meet their obligations and your rights if they do not?
- □ Have you considered updating your standard contracts to account for COVID-19 or similar future public health emergencies?

Tax, Finances & Solvency

- Are your financial records and filings up to date?
- Have you identified steps to mitigate possible financial losses?
- ☐ Are you exploring new sources of funding or negotiating changes to existing investments? Are you aware of the relevant legal considerations?
- ☐ Are you aware of government support or tax relief programmes available to your organisation (e.g. tax breaks, emergency loans or grants, etc.) to help address the COVID-19 crisis?
- Do you understand your legal structure and who will be liable if your organisation cannot, for example, pay its debts?
- ☐ Are you in a situation where you are (or could be) unable to pay debts or continue operations or are at risk of insolvency?
- Are you considering whether to close operations permanently? If so, do you know the steps you need to take to dispose of funds and assets and to settle outstanding obligations, including to employees?

Employees & Volunteers

- Do you know your legal obligations to workers, including workers who are vulnerable or have caregiving responsibilities?
- Do you have a sick leave policy? Do you know your legal rights and obligations in relation to employees who are sick, or not sick but required to self-isolate or quarantine?
- Do you have appropriate health and safety measures in place for your workforce, including for those who can and cannot work from home?
- Do your benefits plans cover medical expenses relating to COVID-19 (if needed)?
- Do you have a policy on working from home?
- Are you aware of government support or tax relief available to you as an employer?
- Do you know your obligations in relation to volunteers?
- □ If you are considering temporary closure, working hour or pay reductions, lay-offs, furloughs or redundancies, do you understand the legal implications?

- □ Have you reviewed your lease? Do you understand your options to vary terms, negotiate interim payment terms or rent concessions, or to terminate?
- Are you aware of any government or other measures that are available to you if you lease or own property, for example, to protect against eviction or give a grace period for mortgage payments?
- Are you in a situation where a landlord or tenant has served notice of termination or is seeking to negotiate new terms? Do you know your rights and options?
- Are you currently negotiating a new lease? Do you know if you are protected if the current COVID-19 pandemic continues or recurs?
- Have you reviewed your insurance policies recently?

) Insurance

- Do you know if you are covered for losses resulting from the outbreak of an infectious disease or virus, including COVID-19? Have you provided notice under such policies?
- Do you know if it is necessary to obtain additional insurance?
